Heba Abd el Gawad is a research fellow at the Institute of Archaeology, University College of London. She specializes in the history of Egyptian archaeology and Egyptian perceptions and representations of ancient Egypt and has co-developed with Prof. Alice Stevenson the AHRC funded project: 'Egypt's Dispersed Heritage: Views from Egypt'. She has led various curatorial roles in Egypt and the UK and has been selected as one of the most influential 21 Egyptian women in 2021 for her community work in the heritage sector. She acknowledges her privilege and training in the colonial discipline of Egyptology and recognizes the rights of the wider Egyptian community in the knowledge production of their past and heritage.

Asif Ali Akhtar is an LSE Fellow in Media and Communications at LSE and earned his Ph.D. from NYU in 2023. His doctoral dissertation, "Television Siyasat," delved into the repercussions of broadcast media privatization during General Pervez Musharraf's regime in Pakistan. Dr. Akhtar's research connects today's media challenges in Pakistan to its colonial history, drawing from archival research at the India Office Records collection. His work received departmental distinction and NYU Outstanding Dissertation Award nominations. Holding an M.A. in Politics from NSSR and a B.A. in International Studies and Economics, he is now developing a book proposal to analyze Pakistan's media and regulatory issues in a global context, encompassing emerging technologies' impact on society.

Oliver Antczak is an anthropologist interested in the heritage and identity relationship, particularly focusing on Indigenous identity in the Southeastern Caribbean. For his B.A. (Leiden University College, 2016) he worked on Margarita, Venezuela. For his MPhil in Heritage Studies (University of Cambridge, 2018) he continued similar work on Bonaire. Since 2019, his PhD at the University of Cambridge (Cambridge Heritage Research Centre) brings the two islands into conversation with Trinidad, researching the impacts of different colonialisms on Indigenous identity and heritage.

Hana Attia is a Postdoc at the University of Salzburg and a Research Associate at the German Institute for Global and Area Studies (GIGA). Her research focuses on economic statecraft. She is particularly interested in the imposition, enforcement, and termination of economic sanctions. Her research has been published in peer-reviewed journals such as *International Studies Quarterly, Journal of Peace Research, European Economic Review*, and *Review of International Economics*. Hana completed her PhD at the University of Konstanz in April 2023 and was previously working as a Research

Fellow at the GIGA. She was a visiting scholar at the American University in Washington DC funded by a Fulbright scholarship.

Christof Brandtner is an assistant professor of social innovation at emlyon business school in France, a CIFAR Azrieli Global Scholar, and a senior research fellow at Stanford's Civic Life of Cities Lab. His research examines how institutions and organizations shape the emergence, diffusion, and implementation of social innovations in cities and their civil society. Christof received his PhD in sociology from Stanford University in 2019 and was a postdoctoral scholar at the University of Chicago's Mansueto Institute for Urban Innovation.

Laura Bullon-Cassis is a Postdoctoral Researcher at the Albert Hirschman Centre on Democracy of the Geneva Graduate Institute. Her doctoral dissertation, awarded with Distinction by the Department of Media, Culture, and Communication at New York University, explored the category of youth in climate discourse with a focus on the lived experiences of young people in UN climate conferences. Her broader research interests are at the nexus of environmental justice, climate activism, and ethnographic approaches to environmental politics. As a Team Leader for the International Institute for Sustainable Development's Reporting Services, she regularly attends UN environmental conferences. She holds a BSc in Sociology and an MSc in Global Politics from the London School of Economics.

Rishika Chauhan is a Post-Doctoral Researcher at King's College London's Centre for Science and Security Studies, based in the Department of War Studies. She has a doctorate in Diplomacy and Disarmament, from Jawaharlal Nehru University, New Delhi.

Tenna Foustad Harbo holds a PhD in Global Studies from Aarhus University, where she is currently affiliated as a Research Assistant. Her doctoral dissertation explores contemporary contestations of epistemic power, and is particularly concerned with the growing transnational, student-led movement promoting pluralism in economics and their consistent calls for reform. Her other research interests include digital protest and contention, cultural expressions of educational critique, and emerging alternative economics. She holds a MA in International Studies from Aarhus University.

Felipe Gaitan-Ammann is an anthropologist specializing in the study of Hispanic colonialism through social archaeology, postcolonial theory, material culture studies, and museum anthropology. He is a proponent of the new field of Afro-Latin American historical archaeology, and have worked extensively on the difficult heritage of the slave trade in colonial Panama. He has also implemented archaeological methods to look into colonial funerary practices and the development of modern lifestyles in early republican urban centers in Colombia. His other research interests include the anthropology of early modern piracy, and the theory and practice of cultural heritage in Latin America.

Tshepo Gwatiwa is Lecturer in Intelligence Studies, in the Department of Security Studies and Criminology at Macquarie University in Sydney, Australia. He is also a Senior Research Fellow (Non-Resident) at the Institute for Pan-African Thought and Conversation (IPATC) at the University of Johannesburg, South Africa. He is editor of Contemporary Intelligence in Africa (Routledge, forthcoming). He is the author of The African Union and African Agency in International Politics (Palgrave Macmillan, 2022). He was co-editor of Expanding US Military Command in Africa: Elites, Networks and Grand Strategy (Routledge, 2021).

Stanley Jachike Onyemechalu is a Gates Cambridge Scholar and PhD Candidate in Archaeology at King's College, University of Cambridge, UK. His research, which was awarded the Emslie Horniman Anthropological Scholarship Fund by the Royal Anthropological Institute, explores the intersections of cultural heritage and the legacies of violent conflicts in the context of the Nigeria-Biafra war (1967-1970). His research interests cut across (post-)Conflict Memory, (post-)Conflict-heritage, Indigenous and Decolonial Heritage, Museum Studies, and Community Archaeology.

Aljosha Karim Schapals is a Senior Lecturer in Journalism and Political Communication in the School of Communication of Queensland University of Technology (QUT) in Brisbane, Australia. He is also a Chief Investigator in the Digital Media Research Centre (DMRC), where he is currently working on a major research project on 'The Value of News', led by Professor Terry Flew and funded by the Australian Research Council (ARC).

Fady Khoury is a postdoctoral fellow at the Edmond J. Safra Center for Ethics at Tel Aviv University. Khoury completed his S.J.D. at Harvard Law School in 2023. Khoury's research is focused on comparative constitutional law and design in divided places. Through case-studies, He explores the utility of sociological constitutional legitimacy as an analytical framework for understanding the dynamics of conflict in divided societies, the utility of federalism and devolution in addressing (some) governance failures in postconflict consociational systems, and the design, function and jurisprudential practices of apex courts in power-sharing systems. His current work is focused more broadly on varieties of constitutionalism in systems of power-sharing.

Hyun Kyung Lee is an Assistant Professor at the Critical Global Studies Institute at Sogang University in South Korea. Her research interests include difficult heritage (colonial/Cold War heritage) in East Asia, transnational heritage networking, heritage interpretation and peace-building at UNESCO. She is the author of Difficult Heritage in Nation Building: South Korea and Post-conflict Japanese Colonial Occupation Architecture (2019). Her co-authored book is Heritage, Memory, and Punishment: Remembering Colonial Prisons in East Asia written in collaboration with Shu-Mei Huang (2019). Her most recent collaboration with Shu-Mei Huang and Edward Vickers, an edited volume titled Frontiers of Memory: Difficult Heritage and Cross-border Politics of Postcolonial Nationalism was published with Hong Kong University Press (2022).

Mathilde Leloup is an Associate Professor of Political Science at the Institut d'Etudes Européennes (Université Paris 8) and a researcher at CRESPPA-LabToP. Two years ago, as an Oxpo Postdoctoral Fellow in the Department of Politics and International Relations (DPIR) at Oxford University, she published a book based on her PhD thesis on the protection of cultural heritage by UN peace operations (Dalloz, 2021).

Márcia Lika Hattori is a Brazilian archaeologist and research assistant at the Spanish National Research Council (CSIC).
